# MEMORANDUM OF UNDERSTANDING (MOU)

This MOU entered in to on 15<sup>th</sup> day of June, 2015 by and between MVP Samaj's Arts, Science and Commerce College, Ozar (MIG) and Saumitra Food Industries, Ozar (SFI)

The aforesaid college is here after referred to individually as Ozar College and Maharashtra State Draksha Bagaitdar Sangh,Ozar as MRDBS, Ozar

# About Maharashtra State Draksha Bagaitdar Sangh, Ozar

Ozar and Pimpalgaon Baswant is leading grape growing centre of Maharashtra. The farmers of these area not only grows and supply the grapes to the India and abroad but also process the grapes for making the raisins and allied grape products. The MRDBS, Ozar is an organization of Grape growers of all over the Maharashtra which solve the problems in cultivation, protection, marketing and export. It also arranges group discussions, seminar lectures and various other things for grape growers.

# 1) Objectives of MOU

- Most of the students studying in the college are from the grape growing farmers community, so these student will get the recent techniques in the grape cultivation
- 2. To promote and enhance the academic interest between college and MRDBS, Ozar

- 3. To foster the self employability among the students in grape marketing.
- 4. Raisin making training for the students.
- 5. Industrial visits and guidance to the students of ozar college.
- 6. Guest lecture of agricultural executives to the students of ozar college
- 7. The college will provide the information to the grape growers about the probable fruiting spurs of the grape plants
- 8. Campus placement as per the needs of M&DBS, Ozar to the ozar college students
- 9. To provide the trained manpower from the college to the industry as and when required

## 2) Technical areas of collaboration

- a. A continuing the quality improvement program to improve the quality of teaching with industrial expertise
- b. To conduct the short term certificate courses in the raisin making
- c. To provide the academic interaction between the MRDBS, Ozar and college for the student's benefits
- d. To provide the necessary help in organizing workshop / conferences and industrial training for the enhancement of skills in respect of faculty, staff and students of Ozar college.
- e. To provide the infrastructure like science laboratory to the MKDBS, Ozar
- f. To facilitate the training for the teachers and supporting staff

# 3) Proposed mode of collaboration

Ozar College and M&DBS, Ozar proposed collaboration through the following:

- c) Cooperation Promotion of education and training in the area of mutual interest
- d) Any other appropriate mode of interaction agreed upon between Ozar College and MRDBS, Ozar, a specific plan will be worked out by the institution depending upon the availability of recourses

4) Terms and Conditions

- o) The cost of development of infrastructure like raisin making should be borne by the Ozar college
- p) The training expenses of the grape grading, Packaging, marketing should be borrowed by the college it self
- q) For visit related to advice and consultancy , travel and other expenses of the teachers and students shall be reimbursed by Ozar college
- r) Use of industrial recourses and infrastructure can be allowed for the limited period of time and availability of raw material
- s) Both Ozar College and MRDBS, Ozar agree to help identify and invite the faculty members and researchers from the other institutes to participate in the conference, seminars industrial training and short term courses conducted by the college
- t) This MOU may be amended, renewed and terminated by mutual written agreement of the institute at any time
- u) Either institute have an right to terminate this MOU up on 60 days prior written notice to the other institute

5) Confidentiality

The Ozar College and MRDBS, Ozar agree to hold in confidence all information data designed by the institutes as being confidential which is obtained from either institute or created during the performance of the MOU and will not disclose same to any third party without written consent of other institute

6) Duration of MOU

This MOU unless extended by mutual written consent of the institutes shall expire in FIVE years after the effective date specified in the opening paragraph, However, on review, the MOU shall be extended for another TWO years by Mutual consents

### 7) Coordinators

The Ozar College designates the Coordinator of MOU as **Prof. D.S. Borade**, Department of Botany, Ozar College and MDBS, Ozar, Ozar for the implementation of this MOU

## 8) Intellectual Property Rights

The Intellectual Property Rights (IPR) that arise as a result of joint research and collaborative activity under the agreement will be worked out on a case to case basis and will be consistent with officially laid down IPR policies of the two institutes
