The aforesaid institute is here after referred to individually as RW and Ozar College.

1) About Renaissance Winery Pvt Ltd,

As an experienced and smart businessman involved in various activities, acres of land is now being brought under cultivation of 'Wine' varieties of grapes. The total acreage under wine grape cultivation is more than 60,000 acres. In this region Chenin Blanc is planted extensively followed by Sauvignon Blanc and Cabernet Sauvignon.

2) Objectives of MOU

- a) To promote and enhance the academic interest between college and industry
- b) To foster the self-employability among the students
- c) Industrial training for the students about wine production
- d) Industrial visits and guidance to the students of ozar college.
- e) Guest lecture of industrial executives to the students of ozar college
- f) Use of industrial board for the practical in the department of Botany

- g) Campus placement as per the industrial requirement to the ozar college students
- h) To sponsor the industrial projects to the ozar college students
- i) To provide the trained manpower from the college to the industry as and when required

3) Technical areas of collaboration

- a) A continuing the quality improvement program to improve the quality of teaching with industrial expertise
- b) To conduct the short term certificate courses in the winery
- c) To provide the academic interaction between the food industry and college for the student's benefits
- d) To provide the necessary help in organizing workshop / conferences and industrial training for the enhancement of skills in respect of faculty, staff and students of Ozar college.
- e) To provide the Training and placement and necessary support
- f) To facilitate the training for the teachers and supporting staff
- g) Guidance for the infrastructure development of the ozar college

4) Proposed mode of collaboration

Ozar College And Renaissance Winery Pvt Ltd, proposed collaboration through the following:

- a) Cooperation Promotion of education and training in the area of mutual interest
- b) Any other appropriate mode of interaction agreed upon between Ozar College and Renaissance Winery Pvt Ltd, specific plan will be worked out by the institution depending upon the availability of recourses

5) Terms and Conditions

- a) The training of the wine production should be borrowed by the college it self
- b) For visit related to advice and consultancy , travel and other expenses of the teachers and students shall be reimbursed by Ozar college
- c) Use of industrial recourses and infrastructure can be allowed for the limited period of time and availability of industrial row material

- d) Both Ozar College and Renaissance Winery Pvt Ltd, agree to help identify and invite the faculty members and researchers from the other institutes to participate in the conference, seminars industrial training and short term courses conducted by the college
- e) This MOU may be amended, renewed and terminated by mutual written agreement of the institute at any time
- f) Either institute have an right to terminate this MOU up on 60 days prior written notice to the other institute

6) Confidentiality

The Ozar College and Renaissance Winery Pvt Ltd, agree to hold in confidence all information data designed by the institutes as being confidential which is obtained from either institute or created during the performance of the MOU and will not disclose same to any third party without written consent of other institute

7) Duration of MOU

This MOU unless extended by mutual written consent of the institutes shall expire in FIVE years after the effective date specified in the opening paragraph, However, on review, the MOU shall be extended for another TWO years by Mutual consents

8) Coordinators

The Ozar College designates the Coordinator of MOU as Prof. Dr S I Patel, Head, Department of Botany, Ozar College and **Mr Shivaji Aher** from Renaissance Winery Pvt Ltd for the implementation of this MOU

9) Intellectual Property Rights

The Intellectual Property Rights (IPR) that arise as a result of joint research and collaborative activity under the agreement will be worked out on a case to case basis and will be consistent with officially laid down IPR policies of the two institutes
