- Mandatory Green Audit
- Avoid the use of all kinds of disposables
- Use only steel/glass/porcelain cups and containers instead of those made of paper and plastic
- Use and throw carry bags are not allowed on the campus

The plants in the campus are scientifically identified and documented through a green audit conducted by Botany Department. Rain water harvesting is effectively implemented in the campus so that exploiting the ground water resources can be minimized.
